1. Personal data

2. Data Processing Systems

3. Consent to the disclosure of Participant information

The board of the association hereby points out that sufficient technical measures have been taken to guarantee data protection. - the personal data can also be retrieved in countries that do not have data protection regulations comparable to those of the Federal Republic of Germany
- confidentiality, integrity (inviolability), authenticity (authenticity) and availability of personal data are not guaranteed.

3. Art. 15 para. 1 DSGVO: Right to comprehensive information and opposition

Pursuant to Art. 15 para. 1 DSGVO, you have the right to request confirmation from those responsible as to whether personal data relating to you will be processed. If this is the case, you have the right, according to Art. 15 DSGVO, to ask the association AEGEE-Bamberg e. V. for comprehensive information on the personal data stored about you at any time.

You have the right to object to the processing of your personal data at any time; this also applies to profiling based on these provisions. In addition, you can exercise your right of objection at any time without stating reasons and change or completely revoke the given declaration of consent with effect for the future.

4 Article 17 DSGVO: Right to deletion and correction

According to Art. 17 DSGVO, you may at any time request the AEGEE-Bamberg e. V. association to delete, authorise and block your personal data.



5. declaration of obligation to comply with the legal data protection requirements for personal data in accordance with the Basic Data Protection Ordinance (DS-GVO)

By becoming a participant of our association you undertake to comply with the data protection regulations of the Data Protection Basic Regulation and to guarantee data secrecy in accordance with § 5 of the Federal Data Protection Act (BDSG). You may not process personal data yourself without authorization and you may not disclose or make available such data to other persons without authorization.
